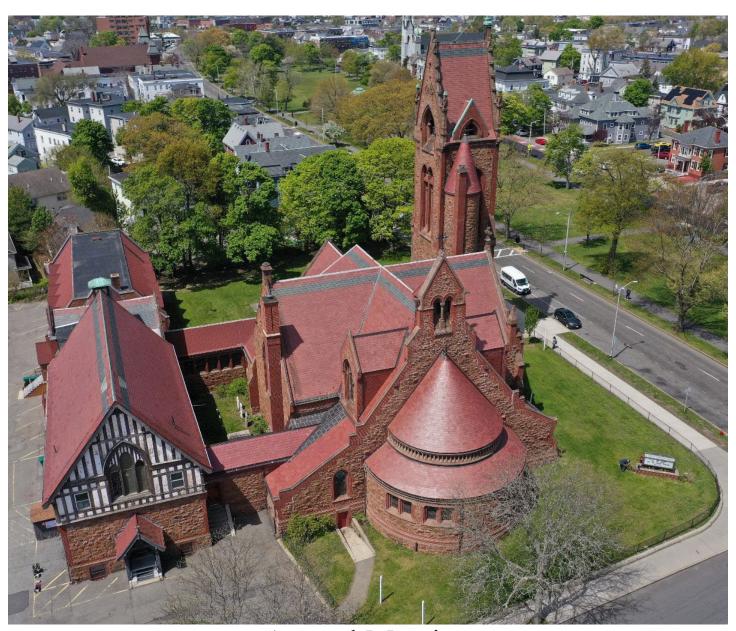

#### REPORT OF THE SENIOR WARDEN

"About the gifts of Spirit my friends I want there to be no misunderstanding... There are varieties of gifts but the same Spirit. There are varieties of service, but the same Lord. There are varieties of activities but in all of them the same God is active in each of us. The Spirit is seen to be at work for some useful purpose... Christ is like a single body with its many limbs and organs, and together they make up one body... Now you are Christ's body and each of you a limb or organ of it."

On September 10, 2022 the Vestry, Reverend Greg and Reverend Canon Martha Hubbard started the Mutual Ministry Review with this passage. We shared what in this passage stood out to us. The responses were pretty much what you would expect; there are varieties of gifts, we work in concert with each other, and we are all part of Christ's body and we need each other.

I start here because this was an exercise that collected all that we at St. Stephen's accomplished in the time of the Covid pandemic. I must admit that when asked, "What did we accomplish?" I struggled for a few minutes to identify anything significant. However, more thought brought more enlightenment. Together we created the following list of accomplishments, some of which happened prior to 2022:

Instituted online worship via ZOOM and YouTube
Membership still here with stewardship
New people in leadership roles
Food pantry stayed open and expanded
Office management improved
Resumed Wednesday Bible Study
Vestry meeting in person with ZOOM option
Prayer list management
Rebuilding after Covid – Pumpkins, Pride Dinner
Calendar Raffle
Started Latino Outreach
Healing divisions in the Parish
Learning about and reflecting on racism and white supremacy at St. Stephen's at each

What we found when looking at who was responsible for these wonderful developments was that a host of people were involved from the Priest-in-Charge, the Vestry, staff, and many parishioners stepping up to do the work we are called to do.

The Mutual Ministry Review will continue going forward. A committee was formed in December and will begin the work of developing a Parish Profile and determining, together with Reverend Greg, what path we will take forward when the third year of Greg's tenure ends.

Other issues addressed in 2022 are those that have posed challenges to us over the years. Fundraising is critical to our budget. The Calendars raised significant money for us. We were fortunate to have a movie company interested in our building to film some scenes and that netted \$24,000. We cannot expect that to occur on a yearly basis. Bill Mulcahy and Jim Moser had the grandest of all flea markets in the dining room for two consecutive Saturdays, which was both lucrative and fun. The Vestry is committed to exploring new ideas for fundraising and would love input from the congregation.

The building continues to challenge us. The buttresses by the front door need repair. Structures North evaluated them and comforted us by saying that the tower was not ready to fall. However, the condition of the buttresses needs to be addressed. The hope is to find some funding through the diocese or other entities to help. Work may begin in the spring.

The security and safety of our people and staff are of the utmost importance. A new system has been installed to better identify people who are at the door on Blossom Street and at the handicap entrance. Visitors may now be "buzzed" in and the cameras and audio are a welcome addition.

The use of our abundant space is also being reviewed. Clean up has begun, first in the pantry area and Mothers Room (thank you Pam & Jay Poppe) and will then venture upstairs to the second floor of the Anderson Building. The hope is to make the space suitable for rental to outside non-profit agencies and/or small start-ups.

Christ the King – we learned in September that a resolution was being entered in to the Diocesan Convention Journal that indicated that many parishes have committed the sin of racism and intolerance over the years. Unfortunately, St. Stephen's was identified by name in the resolution as having been unfair and paternalistic to our African brothers and sisters upstairs. We had no input into the resolution, but are committed to being in conversation with Reverend Joseph and his leadership team to carve a path going forward that recognizes our mutual journey that is built on trust, faith and respect.

Last, but not least is the appearance of the Little Free Library on out front lawn. Many thanks to Bonnie Bishop for shepherding that project to fruition.

Thank you all for doing the work it takes to keep us alive. St. Stephen's needs everyone being the light of Christ in Lynn and the world.

#### REPORT OF THE JUNIOR WARDEN

It is a privilege to serve St. Stephen's as the Junior Warden and help support the work of the people of our parish. As I don't live close to the church, I consider myself working more in the role of "the People's Warden" listening and supporting the many who share their gifts and talents with the church, than "the Property Warden" being point person for the care and maintenance of our property.

That being said, the Senior Warden, Steve Switzer, and I work as a team, and I am apprised of problems and issues that need to be addressed. For instance, we noticed the buttresses around the outside of the church were in bad shape. The engineering firm, that was suggested we contact to assess them and the building, had previously done an extensive survey of the building so we are in discussion with them on our next steps.

In addition to the building's exterior, we are looking at the interior. With the vestry, we are exploring new creative ways to use parts of the Anderson Building (parish house). Ideally, we might house a small non-profit and both be of service to the community and bring in additional income.

Though additional income would be beneficial to help maintain our buildings, we need to give thanks for the many gifts and talents that are already shared within the building, and without, pastorally in the name of St. Stephen's. I give thanks for my fellow vestry people. For those who lead and work at our food pantry, host our Women's group, attend our Bible Study, ran the bazaar. For those who sing, read, serve at the altar, usher, bring up the plates, count the offering, run our Zoom & Youtube broadcasts. For those who come to church in person or online. For those who help with the service or in maintenance of the building in any way –Thank you! For our staff, Bruce Beecroft, who leads our service music, John Norton, who cares for the building, John Churchwell, who mans the office. We are blessed!

### REPORT OF THE PRIEST-IN-CHARGE

"For everything there is a season, and a time for every matter under heaven:

A time to be born, and a time to die;

There is first time for everything, at least for me, having arrived during a continued pandemic and shutdown. This has been the story of my ministry. An example of this is the Christmas parade that passes in front of the church on Christmas Eve. When determining the time for our Christmas Eve service, I was forewarned of the noise that the vehicles make. It was recommended to move the time back by half an hour. A first for me!

No doubt, arriving during a pandemic, has had its challenges. I am grateful to those who have gently reminded me of the customs of this congregation throughout the year.

There have been many "first" times here at St. Stephen's: Our Office Manager completed his first full year of employment on December 14, 2022; Bill Mulcahy and Jim Moser organized a successful Bazaar/Yard Sale in October – a first event in which members of the community entered our space for fun; I was reminded that on the last Sunday of the month of October, Breast Cancer Awareness month, the congregation was invited to wear pink. I was able to wear my pink socks for the first time in two years.

I hope that there will continue to be "first time" events and experiences for all of us here at St. Stephen's. My wish is to encourage all of us to think about St. Stephen's and ask where God might be calling us to venture. We are not alone. An alarming number of congregations in our Diocese are doing the exact thing – asking the hard question regarding how we are to live into the future as disciples of Jesus, as Church.

There is much potential here at St. Stephen's, but we all must be willing to work together, not apart. We continue to learn from the pandemic and its impact on the world, on communities, and on congregations. If anything, we can learn from the African philosophy of *Ubuntu*, which states that to be human is to recognize the humanity of others, even those with whom we disagree.

I am grateful to our Office Manager, John Churchwell, for being a vital support to me. The talent that he brings to St. Stephen's has been a joy, and I have encouraged him to help me make our parish office more efficient. Our new website, weekly Newsletter and organizing the office are but a few of the changes he has completed.

I am grateful to the Wardens and Vestry for their support of my ministry. I am grateful to each of you for your confidence in me, and your support of my last two and a half years as your Priest in Charge. As we both reach the end of my three-year contract, I ask for your prayers to guide us both in what is to come next.

Truly, we are all experiencing "first time" moments, always remember, "For everything there is a season, and a time for every matter under heaven."

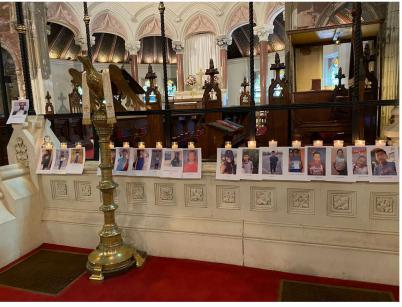

# REPORT OF THE STEWARDSHIP MINISTRY TEAM

In the face of still dealing with the effects from the Pandemic, The Stewardship Ministry Team, with Reverend Perez, kicked-off the 2023, pledge campaign in July, 2022. The Theme, "Come let us go down to the Potter's House and see how The Potter might rework us" was taken from the Book of the Prophet Jeremiah, 18: 1-4. The Theme was wrapped around the Japanese ancient practice of embracing imperfection and the skill of finding beauty in broken dishes by reworking the pottery with glue of gold, platinum or silver, creating stunning new works of art called Kintsugi.

The focus of the Stewardship Ministry Team using this concept, as St. Stephen's strives to move forward amidst a lingering Pandemic, is to find the courage to embrace the new normal with which we are faced, not only in finding beauty in the things that are now but in hope of what we might be able to rework using our time, talent and treasure for the rebuilding of St. Stephen's and preserving its future.

In the Newsletter for the month of October in 2022, fellow Parishioners Carolyn Edwards, Emily Sherwood, William Mulcahy & James Moser and Toby Milner, took us through the journey of their faith stories that brought them to St. Stephen's and why they pledge. Many thanks for inspiring us with your stories; reminding us of our faith stories and the reasons we too must do all we can to support the work of the Church.

To everyone who has submitted a pledge to help meet the 2023 budget goal of \$120,000, we are very grateful; thank you! As of this reporting, we have received 46 pledges totaling \$100,167, leaving a way to go in accomplishing budget. If you have not yet pledged, we invite you to please consider doing so; it's never late to pledge. Every pledge dollar helps, regardless of the amount. ### REPORT OF DIGITAL WORSHIP

Since the pandemic first started, St. Stephen's has offered parishioners a virtual method through Zoom to stay connected and worship together. After St. Stephen's reopened on Pentecost Sunday 2021, online worship was continued through the financial support of the vestry as an outreach ministry of evangelism and a pastoral care ministry. People can watch professionally produced weekly Sunday 10am services and Holy Day services on our YouTube channel directly or join in together on Zoom and watch the service live on a shared screen of the YouTube broadcast. Parishioners who join via Zoom, often stay on after the service and have the opportunity to greet each other and carry on a "virtual" coffee hour.

During 2022, our diocese awarded St. Stephen's Memorial Church a Congregational Development Grant in the amount of \$9,500 (maximum grant amounts are \$10,000) to assist in funding the broadcast production and to purchase additional technical devices. Broadcasts over the last year averaged around 30 views weekly, with high holy days having significant more views. Easter Sunday, April 15, 2022 had 377 views, Pentecost Sunday, June 5, 2022 had 173 views, Christmas Eve service, December 24, 2022 had 85 views and Christmas Day, December 25, 2022 had 49 views.

Tuttle Co. remotely controls our five cameras through a laptop in the church and professionally produces and uploads all videos to our YouTube channel, our Facebook page, and our parish website at a cost of \$250 per production. Chris Trahan and Silvie Prinston are the weekly Zoom ushers.

#### REPORT OF THE PARISH HISTORIAN

Reorganizing and cataloging the archives is progressing slowly. Over the course of many years, historical documents and photographs were stored in various locations throughout the parish building. With materials now gathered in one designated archives space, the long work of sorting, documenting and archivally filing materials is an ongoing process. The parish administrator, under the direct supervision of the clergy serving St. Stephen's Memorial Episcopal Church, records, maintains, and secures all vital records. Other historical parish documents and photographs are stored in the archives of the parish. Cataloging, including photographic documentation of the parish's insured property, and organizing files continues to be an ongoing process, utilizing the current recommended archival care processes. Digitization of parish registers has begun under the care of the office manager, John Churchwell.

During 2022, there were no new purchases made against the Archival Line Item in the budget. As required, the parish office will send a copy of the parish's 2022 Annual Report to the Diocesan Archivist at the Diocesan offices for filing in the diocesan archives.

### REPORT OF THE PARISH TREASURER

#### **Financial Statements**

As we complete the second year since the 2020 COVID shutdown, there are some signs of recovery in our finances. Congregational giving was better than expected, exceeding what was budgeted by almost 14%. Community Gifts income continues to support the parish through our partnership with ECCO and Christ the King as well as occasional building rentals. The Calendar Raffle and Fall Yard Sale were new and successful fundraisers that brought in much needed dollars to the budget. Unfortunately, we were unable to organize a major summer event, which meant we did not reach our 2022 goals for fundraising. Gaps in income continue to be made up by taking a significant draw from our endowment. As for expenses, we have seen substantial increases in the cost of fuel, electricity and office supplies. Salary costs remained steady, and new leadership in the office has allowed for deferred maintenance to be completed, including office clean outs and a new security system. Providing online worship also continued to be a major new expense for the parish, and some of our equipment and broadcasting costs were covered by a diocesan grant. At year end, although we had planned for a higher deficit, better income outcomes reduced the deficit to \$32,089.

Program life in our parish continues faithfully despite so many obstacles, as shown by the activity outlined in the Statement of Financial Position. All designated monies given for specific projects are reported on this document and carried over from year to year. We continue to apply and receive grant funding as well as donations to window and building maintenance. KIC did close its doors this year due to organizational challenges but seed money still exists for a future reboot. This year we also received a grant for Hispanic Ministries for the first time.

#### **Endowment Report**

2022 was not a favorable year for our investments. A continued reliance on our unrestricted endowment at Schwab means that we are impacting principal more and more each year. Economic instability and inflation have chilled the stock market and our unit valuation sunk from \$175 to \$113. The Diocesan Investment Trust (DIT) experienced similar shrinkage, only producing \$17,209 in income this year compared to \$22,000 in 2021.

#### 2023 Budget

Plans for the upcoming year are focused on reviving and refocusing our efforts to bring consistent income into the Parish. The Vestry has set optimistic income goals for fundraising and space rental in order to reduce the deficit. Expenses remain flat, with the only notable changes being a 5% salary increase for the clergy, and raising the budget for utilities to be in line with market expectations for 2023.

The Treasurer's Office is grateful for the faithful service of Virginia Fuller, Nelson Woodfork, Rick Cloran, Marilyn Cloran and Kendra Zimiroski. It is worthwhile to mention that this is one of the longest serving groups of volunteers at St. Stephen's. The expertise and commitment that this group shares with our parish have been invaluable during recent unstable times. We are blessed to have such saints in our midst.

# REPORT OF THE BELOVED COMMUNITY TEAM

In this our eighth year, we focused on exploration of ourselves and how we choose to live out our convictions in the world. We explored the group's past, present, and we are now dreaming about what our future will be. To this end, we continued our journey of personal transformation and this year we decided to work in affinity groups to develop as a group. We are ardently working to determine and act to create a truly anti-racist world.

Our membership continues to be comprised of congregants from St. Andrew's and St. Stephen's. Together, we have worked with ECCO to challenge and dismantle white supremacy in housing and the criminal justice systems on the Northshore. Specifically, in Lynn we worked tirelessly to bring about an unarmed emergency response team. Our efforts brought significant resistance from systems and individuals that are imbedded with white supremacy culture. Our programming was once again underwritten by a grant from the Episcopal City Mission of Boston. In the previous year, 2021, Covid restrictions prohibited us from implementing planned events so we accomplished those goals this year. The European American members recognized that there was work to do for whites with whites. Therefore, they contracted nationally renowned trainer and speaker, Debby Irving to do a workshop. The community response more than exceeded their goals. Participants told them the workshop was eye opening and motivated them to continue to do the work in their lives. As a companion to this effort, the BIPOC members designed and implemented a retreat for BIPOC folks on the Northshore. They met at Adelynrood Retreat Center over the weekend. Donna Bivens, a Courage and Renewal facilitator and an anti-racist facilitator was their guide. The participants reported that they came away renewed and on the path of restoration so they could continue to do the work that was theirs to do. This retreat was followed up by a Resiliency Workshop that occurred over dinner. Finally, this year we experienced growing pains as we took a hard look at the work we had done over the last eight years and where we stood in the fight for racial justice. Liz Magill and Donna Bivens of the Mission Institute facilitated these meetings. We were all challenged to look at ourselves and determine what we wanted to

do in the work to move the dial within ourselves and how we were functioning as a group. We lost and gained members during this process. As a result of all the work we have done over the year, we are committed to doing work in affinity groups. Furthermore, we will continue our work in a multiracial group to dismantle white supremacy in ourselves, our families, and our communities and simultaneously create new concepts and ways of being that will lead us to a new world order.

## REPORT OF THE WOMEN'S GROUP

The Women's Group meets on the second Sunday of the month after the 10:00 service. The group is made up of approximately 30-40 women from both St Stephen's and St Andrew's Church. After a shared potluck lunch, we meet for fellowship and to support one another. We discuss potential outreach projects to the community where we can spend the grant money we have received. We recently received a deanery House of Mercy grant in the amount of \$1,518.50 for which we are very grateful.

This past year the Women's Group spent ~\$2K of our deanery grant funds on multicultural art supplies. Thanks to Helen Patmon for purchasing and Pam Poppe for helping to distribute approximately 12,000 boxes of 24 Crayola Skin Color Crayons and library books highlighting the beauty in all skin colors to 4 elementary schools in Lynn. We also provided the teachers with handouts stressing the importance of inclusivity and how important it is for the kids to see themselves in books and in general. Helen as a substitute teacher, and Pam as a volunteer librarian distributed the crayons and books and Toby helped with deliveries. From Pam: "It was such a joy to look out at the groups of children who were mostly brown and black and give them a box of crayons that they could use to find their own beautiful skin color!" Both Helen and Pam have received letters from the children and teachers saying how very much they appreciated these items from the Women's Group!

# REPORT OF KIDS IN COMMUNITY (KIC)

We are sad to report that, due to a variety of COVID related stresses, the Advisory Board of Kids in Community has made the painful decision to close both our summer and afterschool programs. KIC started in the summer of 2003 under the name Sanctuary with 40 children. It grew every year until in the summer of 2020 when we enrolled about 120 children and met at the Washington Stem school while renovations were being completed to the church's basement. Last summer we served about 25 children with a four week daily camp.

In 2017, responding to requests from families and with a grant from the Diocese, KIC began an afterschool program, providing keyboard and drumming lessons, plus homework help. That program soon doubled in size, to serve about 40 children. We are grateful to all who helped financially. Recent funders include Mission Initiatives at EDOM, Episcopal City Mission, City of Lynn Youth Outreach, Thomas Demakes, The Demoulas Foundation, The American Recovery Act, St. Andrew's Episcopal Church, St. Michaels's Episcopal Church, the Unitarian Universalist Church of Greater Lynn, the Trustees of the Sears Foundation, Someone Else's Child, First Jobs/Mass Hire, the Amelia Peabody Foundation, and private individuals. The UUCGL has been an especially generous donor over the years.

KIC also thrived on people power. Since 2017, Brandon Mayes taught drumming to our children. We have had as many as 30 literacy volunteers who read to and with the children during the summer and helped with homework after school. These folks were not only from St. Stephens, but also from the Unitarian Universalist Church of Greater Lynn as well as St. Andrews and St. Michaels in Marblehead.

Some of our KIC campers grew up to become staff. We hired many Lynn teens as mentors, often as their first jobs. Some became program assistants and a few have chosen to pursue careers in social work, teaching, and child care, in part because of their experiences with KIC. There are also a number of St. Stephen's parishioners who have supported KIC behind the scenes, particularly Josephine Russo, and we are grateful to all of you as well. A special thanks goes out to our directors over the years—Audrey Gutfreund, Sheyla Veras, James Liberge, and Shannon Morrissey. And abundant gratitude to those who served on the Advisory Board—Rev. Jane Gould, Barbara Boucher, Rev. Tom Barrington, Helen Patmon, Nelson Woodfork, Ginny Fuller, Rev. Greg Perez, Suzanne Forgione, Beth Hecht, Patricia Blackmer, and Bonnie Bishop.

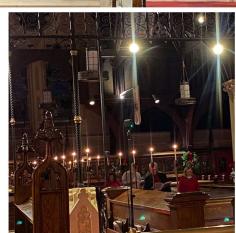

# REPORT OF TRAILS AND SAILS

### **Essex Heritage Trails and Sails Week 2022**

This was another successful year in introducing the public to our beautiful church, its history and especially the Tiffany windows as part of the 2022 Essex Heritage Trails and Sails week. Fifty people listened to a talk in the church by Rick Cloran on our history and creation of our Tiffany windows. Several had heard it more than once. Many marveled that they had been by this building before and never realized what beauty lay inside. Some asked if it still was a working church.

The talks took place on Saturday, September 17 from 10 am to 2 pm. Lucinda McClain assisted people at the desk along with Marilyn Cloran, organizer of the event. Rick was interviewed and appeared on Cable TV concerning his talk. Cards and our 175<sup>th</sup> Momento were on sale.

# REPORT OF THE FOOD PANTRY MINISTRY TEAM

St, Stephen's Food Pantry is open every Friday except the first Friday of the month, from 2:30 to 4pm. Pam Alleyne and Joyce Wallace lead this effort and we are blessed with a wonderful group of volunteers: six from St. Stephen's and another six from the Unitarian Universalist Church of Greater Lynn (UUCGL). The folks from the UUCGL Church do most of the heavy lifting, bringing 10,000 to 11,000 pounds of food into the church. In addition, we have four dedicated volunteers from the Lynn neighborhood, two family members, and two volunteers from St. Paul's in Lynnfield.

We have increased the food deliveries from once a month to twice a month. On the second Friday of the month a trucking company picks up  $\sim$ 7,000 pounds of food from the Greater Boston Food Bank, and on the fourth Thursday of the month a volunteer from the UUCGL Church drives a U-Haul truck to the Salem, MA cross-dock, and he picks up another  $\sim$ 4,000 pounds of food. This helps with limited storage and it allows us to give our clients fresh produce twice a month.

The Food Pantry space has been cleared out and dedicated to exclusively pantry-oriented operations, so that volunteers can more easily access stored food and not need to break down and redo the setup every week. We hope to purchase some replacement (continue on next page)

refrigeration/freezer units once we have assessed how much the space will accommodate. This year our numbers have increased 11 percent from last year. The average number of bags we give out weekly has grown from 68 in 2018 to 196 in 2022. Due to the physical space and refrigeration/freezer storage space available, 200 bags per week is the most we can give out, and we are at full capacity.

**Registration** of new people. With an ever-increasing number of people served, we developed a numbered card system. 2021 was the first year we gave out 1,300 numbered cards. This number was unmanageable. In 2022 we restricted registration times and have registered 661 people. About 1/3 of those people come every week with another 1/3 coming half of the time and the rest of the people come very infrequently. We are registering about 15 new people every month rather than about 60 people every month previously.

**Financially** we have been blessed with grants and gifts, as well as much appreciated donations from parishioners. We are hopeful for the following pending grants that we have applied for this year:

- Grant of \$1,000 from the Eastern Bank Charitable Foundation to be used for Food Pantry needs
- Grant of \$15,000 from the United Universalist Church to be used for Food Pantry needs
- Grant of \$15,000 from the United Way Community Action grant they are giving 16 people \$15K each if they qualify this referred to us by GBFB.

The Food Pantry's end of year balance is \$26,365. The yearly recurring expenses are consistent:

- Trucking costs ~\$2,500
- U-Haul rentals ~\$600
- Bread purchases of ~\$7,000
- Brown paper bag purchases ~\$800
- Miscellaneous food/supply purchases ~\$500

Total yearly recurring costs =  $\sim$ \$11,500
